**Land Protection: Sycamore permanently protects the beautiful natural heritage of southern Indiana by owning land and holding permanent conservation easements on private properties. Over 100 projects have been completed to protect a total of over 10,000 acres. We own, manage and restore more than 6,000 acres of forests, wetlands and grasslands, including formerly mined or farmed land. Sycamore maintains and builds trails for free public use at 16 nature preserves to enable environmentally friendly recreation and education. Nearly 4,000 acres of privately owned properties have been protected through conservation easements to protect their conservation values. Additional resources are invested to protect an additional 10,000 acres owned by others.**

**Land Stewardship: On land that we own, we manage for ecological health. With input from experts in ecology and environmental science, and the help of volunteer land stewards, we plant trees, eliminate invasive plants, and remove refuse. We also manage our public nature preserves for environmentally friendly public use by providing trails, parking areas, and educational signage. On private properties for which we hold conservation easements, we thoroughly monitor and report on each property through regular site visits to ensure that conservation protections are enforced.**

**Environmental Education: Building an understanding of and appreciation for nature is critical to our mission of conserving land and creating a healthy environment for current and future generations. In the past year we also had over 5,000 participants in our interactive programs at schools, at our preserves and other properties, and with community groups throughout southern Indiana. Partnering with schools, we build native plant gardens and other habitats on schoolyards. Thousands of people of all ages and abilities also visit our public nature preserves and other properties to hike, birdwatch, photograph, and enjoy the physical and mental benefits of being in nature.**

Because of severe limitations on use, sale or transfer of these easements and because the limitations are, for practical purposes, inextinguishable, Sycamore considers them to be of essentially no value in the hands of the organization. This is not a reflection upon the valuation of the donation. The donations, supported by independent appraisals, reflect the value surrendered by the donor but not necessarily the value at which Sycamore should recognize the transaction. The recognition of Conservation Easements at no value is in keeping with customary practice by similar organizations.
