Land Acquisition and related expenses: Sycamore permanently protects and preserves the beautiful natural heritage of southern Indiana. We protect over 5,000 acres of forests, wetlands and formerly mined or farmed lands and we do not allow commercial timbering on land that we own. We manage our 16 free public nature preserves to enable environmentally friendly recreational opportunities. Sycamore holds conservation easements on nearly 4,000 acres of privately held land to maintain the conservation protections placed on these properties. We have invested financial and other resources to protect an additional 10,000 acres, owned by other organizations.

Environmental Education: Building an understanding of and appreciation for nature is critical to our mission of conserving land and creating a healthy environment for current and future generations. Over the past year we also had over 5,000 participants in our interactive programs at schools, at our preserves and other properties, and with community groups throughout southern Indiana. Partnering with schools, we build native plant gardens and other habitats on schoolyards. Thousands of people of all ages and abilities also visit our public nature preserves and other properties to hike, birdwatch, photograph and enjoy the physical and mental benefits of being in nature.

Land Stewardship: On land that we own, we manage for ecological health. With input from experts in ecology and environmental science, and the help of volunteer land stewards, we plant trees, eliminate invasive plants, and remove refuse. We also manage our public nature preserves for environmentally friendly public use by providing trails, parking areas, and educational signage. On private properties for which we hold conservation easements. We thoroughly monitor and report on each property through regular site visits.

Sycamore considers them to be of essentially no value in the hands of the organization. This is not a reflection upon the valuation of the donation. The donations, supported by independent appraisals, reflect the value surrendered by the donor but not necessarily the value at which Sycamore should recognize the transaction. The recognition of Conservation Easements at no value is in keeping with customary practice by similar organizations.

These funds are held for the specified purpose of the donor: stewardship, land acquisition, operations, environmental education. The earnings from these invested funds are used to further the purposes of that fund.

During 2017, the board determined that funds previously set up as permanently endowed for the maintenance and upkeep of the Cedar Crest property, were actually temporarily restricted assets, according to correspondence received from the donors. The balance of those assets, \$176,066 were transferred to temporarily restricted net assets. In order to show the progression on the Form 990 of amounts previously reported, this amount was netted against contributions received during the current year totaling \$260,485, resulting in a net contribution of \$54,099, and with transfers in of \$30,320, show total endowment fund contributions of \$84,919. This amount is reported on Part V, Line 1b in column (a) on the Schedule D that is attached to this form 990.
